# "MILYONARO SA RECEMPCO"

#### **RAFFLE MECHANICS/PROCEDURES**

#### I. **REQUISITION**

- A. Only a REGULAR MEMBER OR ASSOCIATE MEMBER by EMPLOYMENT can request personally or through email for RAFFLE TICKETS.
- B. ASSOCIATE MEMBERS by RELATIONSHIP may get raffle tickets for themselves.
- C. Every regular member and associate member by employment is encouraged to buy and/or sell a minimum of (1) ticket booklet with ten tickets and a maximum of ten (10) booklets during his/her first request for tickets. Additional tickets may be requested, upon payment of previously issued tickets.

# **II. DISTRIBUTION OF TICKET BOOKLETS**

- A. Request for booklets may be personally received by the members at any RECEMPCO office or sent in bunch/bundles by RECEMPCO to the members through the RECEMPCO point person at their respective REDOs and or OPES.
- B. Requesting members shall sign the acknowledgment receipt printed for the purpose.

# III. PAYMENTS FOR THE TICKETS SOLD

- A. Requesting members shall pay/remit the tickets sold through RECEMPCO PNB SA number 3133 10039 689 the soonest possible time. They don't have to wait for all the ticket booklets to be sold.
- B. They may request for additional tickets equivalent to the number of tickets sold with the corresponding payments/sales remitted to RECEMPCO.

# **IV. RETURN OF SOLD TICKETS**

- A. The requesting member shall return the booklets /stubs or sold tickets to RECEMPCO through their OPES /REDO or directly by themselves.
- B. The OPES/REDO will consolidate all returned tickets and send these to RECEMPCO via a courier/forwarder.
- C. RECEMPCO will reimburse the OPES/REDO the fee for the courier/forwarder.

#### V. RETURN OF UNSOLD TICKETS

A. The requesting member(s) shall return all unsold tickets to RECEMPCO on or before 15 February 2025 so that the coop can still sell the remaining tickets.

# VI. UNRETURNED AND UNREMITTED TICKETS

A. Unreturned/unremitted tickets as of February 20, 2025 shall not be included in the raffle. It shall be the responsibility of the requisitioning members to return the ticket buyers the amount paid on unreturned tickets.

#### VII. UNRETURNED BUT REMITTED TICKETS

A. Unreturned tickets already paid and remitted to RECEMPCO on or before 28 February 2025 shall be included in the raffle.

# VIII. CLAIM FOR WINNING PRIZES/TICKETS

- A. The ticket buyer whose name appears on the winning ticket stub shall be considered the winner, to the exclusion of other claimant(s). RECEMPCO shall post on its FB account and its offices the list of the raffle winners, except the name of the one million pesos winner. Only the ticket number and the island group (Luzon, Visayas, Mindanao) will be provided.
- B. The winning buyer shall present his/her winning ticket when claiming for the winning prize. He/ She shall present a government-issued ID or other authentic identification documents to establish his/her identity.

# IX. MISSING OR LOST TICKET

A. If the raffle winner, whose name appears on the ticket stub in possession of RECEMPCO, cannot produce his/her winning ticket, he/she must execute an affidavit of loss stating the circumstances surrounding the loss of the ticket and shall present the appropriate documents that he/she is the person whose name appears on the winning ticket stub.

# X. PERIOD TO CLAIM WINNING PRIZES

- A. A winner shall claim the prize not later than December 31, 2025.
- B. Unclaimed prize(s) will be forfeited and shall be added to the RECEMPCO fund for community projects.
